Additional Terms and Conditions

The terms and conditions set forth below are an integral part of the order set forth above.

- 1. Proofs.** Prints will be provided to customer. These Prints will be your property.
- 2. Fee.** Customer shall pay a fee, in advance, of \$750.00 to reserve the photography time for the portrait. Until the fee is received, Shoreline may cancel the reserved time. The fee is nonrefundable.
- 3. Additional Rewards.** If anyone in the wedding party hires the photographer to photograph his/her family while at the beach attending the wedding, either a few days before or after the wedding, the Bride will receive a free 11 x 14 canvas photograph from her wedding, selected and professional printed and mounted by the photographer.
- 4. Services Provided.** The fee shall cover all photography beginning two hours before sunset and ending at sunset and shall include pre-wedding portraits, pictures during the service and post wedding pictures. All photography will cease when the available light is gone. There will be no indoor photography. All individual portraits, group portraits and wedding service portraits are included. If Customer desires any particular photographs, please advise the photographer.
- 5. Negatives and Copyrights.** Shoreline Portraiture hereby assigns to Customer the full copyright and ownership of the negatives. Customer may make copies, duplicates, etc. as is usual and customary with negative ownership.
- 6. Studio's Use of Photographs.** Unless otherwise specifically agreed herein, Shoreline Portraiture has the right to use the photographs from this assignment for the purpose of creating samples, displaying samples of work created by Shoreline Portraiture, entry in photographic exhibitions and other photographic contests, editorial or art displays and general display for Studio and Customer grants such a license to Shoreline.
- 7. Liability of Studio.** In the event that this Order cannot be completed due to an Act of God; strikes or other labor disturbances; action or regulation by any local, state or Federal governmental unit or agency; any event considered a "force majeure"; or any other event or act either within or outside the control of the photographer, Shoreline Portraiture's liability to Customer shall be limited to return of Customer's fee.
- 8. Miscellaneous.**
 - a. Shoreline Portraiture reserves the right to make an additional charge to Customer if the usage and purpose of the Order is other than use as personal photographs that will be displayed not for commercial gain.
 - b. This Order is binding upon the parties, their successors and assigns and may only be altered in writing signed by both parties.
